4. Speech by Rik Hodgson, HIV Scotland

Rik began by challenging the stereotypes associated with older people, sexual activity and sexual health generally. He discussed some of the particular challenges associated with aging with HIV, highlighting the unchartered territory now being entered as people live longer with HIV. Rik stressed the importance of increasing both awareness and understanding of sexuality and sexual health in relation to older people amongst health professionals to ensure that services were appropriate and sensitive.

4. Speech by Katherine Brookfield, The University of Edinburgh

Katherine detailed the research being done as part of the Mobility, Mood and Place study to explore how places can be designed collaboratively to make pedestrian mobility easy, enjoyable and meaningful for older people. The study explores how the way in which we experience environments influences our mood and, in turn, our willingness to be active, using both subjective and objective approaches. There is wide potential to translate the co-design model employed by the study to different contexts, and to open up the design process. In doing so, the aim is to expand the number of people involved in decisions that affect them to improve the quality of those decisions.
