Matters arising

Comments and suggested changes to Police Scotland's Information Leaflet for Survivors were forwarded to DCI Henderson. DCI Henderson thanked the group for our input.

The group asked if there has been any update following this communication. It was agreed we would contact DCI Catriona Henderson to enquire on progress and request copies of the new leaflet once it is finalised. **Action Anne**

Future Work Programme

There was a brief discussion on progress on the above which has been problematic due to constraints of time by the sub group; however a draft questionnaire was distributed to members requesting initial feedback. It was felt there may have been some misunderstanding on the purpose of the questionnaire and that it is not meant to be an academic exercise but more a Community Development approach to gather some basic information and to ascertain if the development of a Network Model might be of interest to survivor agencies. Treasurer's Report

NSPCC: The Right to Recover Report Presentation

The group thanked Rachel and Alison for their excellent Report and presentation. There was a full discussion which highlighted that little has really progressed for children for many years and is an indictment on what priority vulnerable and traumatised children are given by decision makers. There were some questions on why the 3rd Sector was not involved in the facilitated discussion groups by NSPCC. Janine also pointed out that there has been services provided to children in Clackmannanshire by Open Secret and this was not recorded in the Report.

Johann and Margaret had lodged a motion in the Parliament on the findings of the Report; they had unfortunately been unable to secure a slot for a member's debate. The NSPCC may wish to consider lodging a Petition to the Scottish Parliament on the lack of services for children who have experienced sexual abuse.

Rachel and Alison requested membership of the group which was unanimously agreed by those members present.

Anne requested a brief of the Presentation to send out to members. Rachel and Alison will send this for circulation. **Action Rachel and Alison**

NSPCC: Rise in sexual offences against children in Scotland
