Welcome

Emma has a personal interest on reform for the legal requirement for collaboration and how this denies justice to survivors.

Matters arising

Police Scotland's Information Leaflet for Survivors

DCI Henderson had been in touch with the penultimate version of the leaflet for final comment. Anne and some members of the group provided further feedback and some suggested changes.

Invitation to Cabinet Minister for Justice

As Mr Matheson has left this post we will contact Humza Yousaf MSP the new Minister to attend one of our meetings. It was agreed we approach him in the vein of informing him of our work and the issues that survivors of childhood sexual abuse face in the justice system and to find out how we can improve justice for survivors. Johann also would like an update on the In Care survivor's compensation scheme. **Action Johann and Anne**

Adverse Childhood Experiences Cross Party Group

There were some concerns as ACEs formed part of the original Petition and the National Strategy for survivors of childhood sexual abuse and appears to have been 're-invented'. Anne and Janine attended and were given an opportunity to highlight the number of ACEs that survivors of CSA experience (on average six). We recognised that the ACEs group is concerning early years and young people. There will be thematic groups throughout the year as part of the ACEs CPG work.

Break the Silence, Moira Anderson Foundation and Wellbeing Scotland mentioned a crossover as they work with young people as well as adults and some concern about medicalising adverse childhood experiences was expressed. It was agreed we would keep links open with the group and attend relevant meetings in the future. **Action Janine and Anne**

Mapping Exercise: Update

The sub group carried out a mapping exercise for those who support CSA survivors but only seven (including Wellbeing Scotland) responded. It was decided we reissue to our mailing list and other groups.

It is agreed to have an umbrella organisation to enable survivor agencies, survivors and individual professionals in the field to unite and work together would be welcomed. This would give consistency, communication and research possibilities. It would also enable influence on policy direction. **Action Janine, Anne and Carol**

Suggestions for future presentations and events

There was discussion on how we can direct some new growth and members to the group as well as have people with an interest, including researchers and PhD students, who might not wish to join the group to attend events and having these separate to meetings. It was agreed that any talks and events would be scheduled and advertised well in advance. Action Anne and Janine with input from Johann and other members of the group
