

SPCB Privacy Notice

This privacy statement explains how we collect and use personal information about you for the following process:

International Relations Office - Processing CVs of External Visitors

The categories of information processed

Normal category data: Name, Place of Birth, Date of Birth, Professional Background, Education, Marital Status

Special category data: Organisational or Professional Associations which may include political views or affiliations or trade union membership.

Source of the information

This information is provided to us by visiting foreign Parliamentarians, Ambassadors and Officials coming to the Scottish Parliament or their staff on their behalf.

The purpose(s) of the processing

The purpose of obtaining and processing this information is to enable the IRO to create briefing material provided to the SPCB staff and Members of the Scottish Parliament taking part in the delegation party.

The legal basis of processing

The legal basis for the processing of normal and special category data is that it is necessary for a task carried out in the public interest or in the substantial public interest (Art 6(1)(e) GDPR, section 8(d) DPB and Art 9(2)(g) GDPR. The interaction of the SPCB, SPCB officials and MSPs with foreign administrations, government officials and ambassadors is a core function of the SPCB and the preparation for such an event is necessary to carry out that function. The full and effective preparation of Scottish Parliament officials for meetings with foreign visitors is in the substantial public interest.

Data sharing

We share this information with internal SPCB Staff and Members of the Scottish Parliament only as far as necessary. This is not shared with any other third party involved with the visit. The data sharing with Members of the Scottish Parliament has the legal basis outlined above.

Retention of data

The information is stored electronically with security permissions in place and deleted within two years in line with Records Management Policy. This retention period is currently under review and this privacy notice will be updated when necessary to reflect any changes.

Your rights

The GDPR sets out the rights which individuals have in relation to personal information held about them by data controllers. These rights are listed below, although whether you will be able to exercise each of these rights in a particular case may depend on the purpose for which the data controller is processing the data and the legal basis upon which the processing takes place.

Access to your information – You have the right to request a copy of the personal information about you that we hold. For further information, see our Data Subjects' Access Requests Policy.

Correcting your information – We want to make sure that your personal information is accurate, complete and up to date and you may ask us to correct any personal information about you that you believe does not meet these standards.

Deletion of your information – You have the right to ask us to delete personal information about you where:

- You consider that we no longer require the information for the purposes for which it was obtained.
- You have validly objected to our use of your personal information – see *Objecting to how we may use your information* below.
- Our use of your personal information is contrary to law or our other legal obligations.

Objecting to how we may use your information – Where we use your personal information to perform tasks carried out in the public interest then, if you ask us to, we will stop using that personal information unless there are overriding legitimate grounds to continue.

Restricting how we may use your information – In some cases, you may ask us to restrict how we use your personal information. This right might apply, for example, where we are checking the accuracy of personal information about you that we hold or assessing the validity of any objection you have made to our use of your information. The right might also apply where this is no longer a basis for using your personal information but you don't want us to delete the data. Where this right to validly exercised, we may only use the relevant personal information

with your consent, for legal claims or where there are other public interest grounds to do so.
