What plans, measures and strategy are in place to help pupils catch up following the impact of the pandemic on school education, particularly for those moving from primary 7 into high school?

Falkirk Council Children's Services Education Division has maintained its fidelity to the three over arching priorities for the Service which are:

Raising Attainment & Achievement:

Raise attainment for every child and young person and enable them to make excellent progress through their learning journey 3–18yrs.

Wellbeing, Equality & Inclusion:

Improve processes to support attainment and positive destinations for Falkirk's vulnerable children and young people.

Skills & Attributes Development:

Improve attainment and positive destinations for Falkirk's young people.

Since March 2020, our response and recovery plans have provided ELCCs and schools with support and guidance for the operational and strategic management of sustaining quality learning experiences for all children and young people whether that be face to face or remotely.

Throughout the pandemic, the service and school Improvement team have worked in collaboration and partnership with Early Learning and Child Care Heads of Centre, Primary, ASN and Secondary headteachers. Together we have created a

supportive framework of guidance and support within which ELCC and school teams can work flexibly and creatively to meet the unique needs their settings.

We are proud of the adaptions, developments innovations to learning, teaching and communication that have kept our educators connected to children, young people and their families.

Assessing the quality of remote learning experiences has been a focus for all of our settings. The use of the Microsoft Teams insight function and other processes have enabled teams to track and monitor the level of pupils' engagement.

Our Blended, then Remote Learning Guidance set clear expectations of face to face engagement with children and young people. Along side this we worked with senior leaders and our Connected Falkirk digital learning team to create website for support and resources that can be accessed by learners, parents and staff.

Our Service and School Improvement Framework site has continued to provide strategy, support, professional learning opportunities and resources.

ELCC and Primary 1 - 3 returned on the 22nd February. This time has been well used to assess where children are in their learning and to plan targeted support and interventions for those who require it.

On the 15th March we welcomed back our primary 4 -7 pupils full time and our S1 -S6 pupils in a blended approach. The same focus on assessing where our pupils are is planned. SSI officers and headteachers are already working together to identify what further supports may be required to move learning forward at individual school level, from the service and nationally.

Assessments (SNSAs) performance, Curriculum for excellence levels and percentage of children requiring additional support.

FCCS updates its guidance for the implementation and analysis pf SNSAs annually. P4,7 and S3 did their assessments between October and December 2020. Primary 1 will be assessed between April and May. This provides further diagnostic information as part of the suite formative and summative assessments that will be used.

In addition, the latest Service lift of current Curriculum for Excellence(CfE) levels attainment data for all stages in the Broad General Education P1 - S3 has been analysed to provide schools with current CfE assessment data by:

- Individual school
- Cluster group (geographical association with secondary school)
- Neighbourhood Group similar Scottish Index for Multiple Deprivation (SIMD) and FME demographic

Targets are currently being set in preparation for the Scottish Government Achieved Curriculum for Excellence Levels (ACEL) lift in June

Transitions for children of all ages and stages have been considered in all of our response and recovery plans. We have provided more detailed support and guidance for the key stages of ELC into Primary 1 and for P7 in first year. In 2020, the creativity and efforts of teams to make this as robust and supportive as possible for families was tremendous in Falkirk. Digital approaches were developed to provide children and young people with virtual tours, introduction to staff and family learning activities. Door to door drop offs of resources and information were common.

Digital Support

Digital learning was a priority for Falkirk Council long before the COVID -19 pandemic. Our Connected Falkirk programme was initiated in 2019.

ELCCs and schools in Falkirk have embraced the use of digital technology to connect with children and young people and to deliver. Equity is a driving force for us. Schools used and shared their existing devices with families who needed them. Pupil Equity Funding has been used to provide more devices and internet access.

The <u>Connected Falkirk</u> programme has provided further devices, connectivity, technical support and professional learning.

Schools have accessed digital reources from the Scottish Government Connected Scotland fund.

In Falkirk, those who have needed support to be connected, online and learning have received it.



Transition approaches have been further sustained and evolved. Primary 7 -S1 transition started last term. Our secondary schools have dedicated P7 transition websites and are already planning for a blend of continued virtual experiences with face to face learning and activities as soon as it is safe to do so.

We recognise that the pandemic has impacted on traditional P7 residential experiences in 2020 and again this year. Many of our falkirk schools organise these trips with their cluster schools. We value the skills, attributes and connections that children devlop through these experiences. In reponse we are collaborting with our active schools and outdoor learning colleagues to pool resources to provide a targeted programme of activities for all Falkirk Council's P7 pupils in term 4.

Our secondary school headteachers and leadership teams continue to work together to plan for and meet the latest expectations set out on the 3rd March publication of the Scottish Government's "Guidance for preparing inschool and remote learning for S1 - S6."

S4-6 learners completing National Qualifications have been prioritised for in-school time in order to deliver the Alternative Certification Model (ACM) that has been developed.

In school learning and teaching of critical practical work in relation to qualifications in 2021 that can only be carried out in school, continues.

Schools have communicated effectively with pupils and parents to share their rationales and arrangements for the timetabling of in school learning for all pupils.

Extensive and intensive planning has ensured that pupils are able to be in school whilst adhering to the COVID-19 restrictions and safety protocols.

Service and School Improvement officers continue to work closely with senior leaders to manage the balance between in-school and remote learning at individual school level, based on local circumstances. Our secondary school teams are very well prepared to meet the needs of different groups of learners. Commendably, this has been achieved whilst still providing key worker provision, non-class contact cover and remote learning. We hope that the complexity of this task is recognised by the Education and Skills Committee.

In addition to the in-school study support being offered, Falkirk's secondary schools will be supporting pupils to participate in the Esgoil Easter School.

We will work with our schools to continue to contribute to the Esgoil study support and learning offer for BGE stages and senior phase in term 4.



Whether any school building capital projects have been delayed as a result of the pandemic.

As a result of the pandemic, specifically the closure of construction and related industries as part of the first national lockdown, eleven capital projects relating to 1140 hours expansion of early learning and childcare (ELC) were delayed by a number of months beyond the original planned timescale.

This number represents 21% of all local authority-run ELC settings. The removal of the statutory implementation date of August 2020 provided the opportunity to reassess project plans.

No primary or secondary schools have been affected.

What will be the immediate priorities as pupils again return to in-school learning?

In Falkirk Council we are embracing the positive legacies from the changes we have had to make to learning and teaching.

Our priorities are to celebrate where children and young people are in their learning. We aim to move learning further forward. We know where our pupils are with their learning now, we will know even more about this as they all return. Our aim is to reassure pupils and parents that we know where we want our pupils to be, we have plans and will make more plans with children and young people on how to get them there.

Maximising the face to face time that we have with our pupils is critical. Support staff will be redeployed in each

setting to work with those who need additional help the most.

We will continue to provide challenge for those pupils who have sustained good progress and there are many.

We recognise that remote learning suited many pupils, plans are already in place to sustained blended approaches to learning to sustain personalisation and choice.

Recovery planning has focussed on literacy, Numeracy and health and wellbeing. The expectations that children and young people experience a broad general education remain. One of our main priorities is to create a supportive framework that helps schools to assess children and young people skills and attributes development across the curriculum.

We will spend time with our teams over the next few weeks to set the expectations for ELC and school evaluation, contextual analysis and improvement planning and reporting to ensure that progress and achievement are recognised and plans are in place to move learning forward.

Work force support and development is integral to all of our improvement work. This will remain a key priority as the full workforce returns. We will continue to provide facilitated sessions that bring leaders and practitioners together to chare, problem solve ad plan.

We have Got this!

One of Falkirk's greatest strengths is the culture of partnership for improvement between the central team, ELCCS and schools.

This has become all the stronger during the pandemic.

We have stayed connected and collaborative throughout. We have evolved and increased opportunities and programmes which enable:

- Gathering and sharing of effective practice
- Connecting practitioners across all sectors
- Professional learning networks for support for learning assistants, support for learning teachers, secondary subjects, ELC and primary practitioners.
- Leadership development for aspiring leaders, DHTs and newly appointed Headteachers
- Facilitated, small group Leading "Well" sessions for Heads of Centre and Headteachers
- ELC, Primary and secondary Improvement partnerships



How and when does the local authority plan to assess impacts of the pandemic on learning and wellbeing?

Supporting and monitoring the wellbeing of our school teams and communities has been, and continues to be, essential.

Our ELCC and school leaders, practitioners and support teams are to be applauded for their resilience, commitment and collective endeavours to keep children and young people safe, confident and learning.

The wellbeing of staff and children has been front and central to all aspects of our response and recovery plans. This focus is in no way diminished as children, young people and staff come back together.

The level and quality of pupils interaction has been monitored in both periods of lock down. Between August and December tracking monitoring and assessment was integral to day to day learning and teaching. Holistic approaches to assessing children's wellbeing, progress achievement and attainment are already underway.

Schools are currently reviewing the data they have gathered to plan for further assessments as children return to full time education.

ELCC and school teams are welcoming children and young people back with positivity, ambition and aspiration. They are celebrating and evaluating what has been achieved and planning carefully for next steps.

There is a joint determination in Falkirk to harness the energy, resilience and high levels of engagement that children and young people have returned with. We will continue to be adaptable and responsive based on the data generated from previous, current and further assessments of both wellbeing and attainment.

We have a clear sense of shared responsibility and accountability to get it right for every child in Falkirk. We are working with partner services to ensure that those most vulnerable and those in need of additional help in nursery, in school and at home are appropriately supported.

Connecting those who support additional needs has been a priority. Microsoft Teams networks are in place to enable support for learning teachers (SFLTs) to share ideas, signpost resources, successful interventions, effective strategies and relevant information. Colleagues can ask for support/advice from central officers or each other. Professional learning sessions and opportunities have been signposted team members and facilitated by central officers. This professional learning network is providing a strong link between SFLTs and the central team and is another asset to our suite of assessment and improvement approaches

Support staff have had a pivotal role all aspects of our work. ELC and support for learning assistants (SFLAs), home link/ welfare officers have all contributed to our collective efforts to reach out to families during periods of lock down and to keep the connection between ELC, school and home. As with SFLTS we have a Microsoft Teams professional learning network for SFLAs. We have also increased professional learning and training opportunities for this important workforce group. Their expertise and knowledge will contribute to our holistic assessment of children's wellbeing, progress and achievement.

Falkirk is placing significant importance on working with parents and carers to build on their evaluation of their children's remote learning experiences, strengths and needs. In addition we are refreshing our parental engagement strategy to sustain and enhance the many innovations in communication, collaboration and consultation which have developed over the last 12 months.

Wellbeing

The FC Children's Commission are working with the Community Planning Partnership Mental Health Group to develop a public page with children, young people and parents to understand what they need to support their MHWB. This is a priority focus area for the new Falkirk Council Children's Services Community Mental Health and Wellbeing Service supported by Scottish Government funding.
