4. **Work programme (in private):** The Committee considered its work programme. The Committee agreed its approach to phase one of an inquiry on Primary Care. The Committee also agreed to conduct a short inquiry on health hazards in the healthcare environment.
5. **Healthcare (International Arrangements) Bill 2017-19 (UK Parliament legislation) (in private):** The Committee considered a second report and agreed to further consider the report at its next meeting.
