#### **REQUEST FOR INFORMATION: 2022-671810**

We acknowledge your request for the following information:

I would like to make a Freedom Of Information request for the names of any MSP's who have claimed on their expenses for the fitting of interlinked smoke detectors to comply with current legislation.

Your request was received on 14 February 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

We have interpreted your request as for information about installation of interlinked fire alarms into all homes in Scotland.

The information that you have requested is not held by the Scottish Parliament and therefore we cannot provide it to you.

The Members Expenses Scheme does not cover the installation of interlinked fire alarms or smoke detectors in a private home. The cost of fitting interlinked fire alarms or smoke detectors would be a personal matter and expense for the individual Member.

Members can claim the costs for installation of interlinked fire alarms or smoke detectors in their local offices and in this event the costs would be published in line with other Members' expenses. The Allowances Search Tool enables you to search by financial year and then use the various filters to refine your search, which will enable you to find information about expenses claims by MSPs.
