REQUEST FOR INFORMATION: 2022-672394

We acknowledge your request for the following information:

Please provide copies of any advice sought by the Scottish Parliament Corporate Body to inform its decision-making about access to the Parliament building by members of the public in response to the Covid pandemic, including advice from Public Health Scotland and the Scottish Government. Please provide advice sought for the period from 1 September 2021 onwards.

Your request was received on 1 March 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

At the beginning of the pandemic a Covid Working Group (CWG) was established and chaired by the Parliament's Deputy Chief Executive, with expertise from our Legal, Health and Safety, Facilities Management and operational teams.

The CWG has analysed the Scottish Government regulations and guidance at every iteration and discussed the impact of every statement from the First Minister. The CWG provides recommendations to the Scottish Parliament's Corporate Body on the changes required to meet the letter and spirit of regulations and guidance, including public access to Holyrood.

The CWG consults all publicly available material, including guidance and regulations published by the Scottish Government, Public Health Scotland and Health and Safety regulators. It has not requested any additional information over and above what is publicly published by the government. We also speak to other organisations in Scotland and where appropriate other legislatures in the UK. When deciding on our approach we consider this advice and guidance against our strategic intent which is to safely and sustainably deliver parliamentary business.

When considering our policy for public access, due regard was given to regulations and guidance and safely running parliamentary business. Public access resumed on 31st May 2021, for committee witnesses, time for reflection speakers and constituency related or business meetings. This was extended on 21st February 2022 to include the re-opening of the Chamber gallery for MSPs' constituents for First Minister's Questions and Members Business. Tours for those meeting with a Member were also reintroduced at the same time as well as Education visits.

We are currently planning for re-opening to the general public.

In line with the technical requirements of FOI(S)A we have provided a notice advising that the information you have requested is not held by the Scottish Parliament.
