### **REQUEST FOR INFORMATION: 2022-682157**

We acknowledge your request for the following information:

Under the Freedom of Information (Scotland) Act 2002 (FOISA), I would like to request the following information:

- 1. A list of repairs and annual maintenance carried out to the Scottish Parliament's roof in the past three years.
- 2. A list of the total costs for repairs and annual maintenance to the Scottish Parliament's roof in the past three years.
- 3. A budget forecast for the next three years for identified repairs and annual maintenance of the Scottish Parliament's roof.

Your request was received on 28 November 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

Responding to each part of your request in turn, the position is as follows:

1. A list of repairs and annual maintenance carried out to the Scottish Parliament's roof in the past three years.

The Scottish Parliament roofs are generally of a stainless-steel standing seam type construction, except for Queensberry House which is a tiled roof. These are all circa twenty years old with an expected lifespan in excess of forty years. No major repairs have been carried out in the last three years. Planned and preventative maintenance (PPM) is provided from the High Level Maintenance contract which covers cleaning and coating services for all parts of the site following a PPM programme.

Reactive repairs arising due to weather and normal deterioration are carried out jointly from this fixed cost service and from an approved subcontractor where the work is more specialist.

During the last three years some further project work has been carried out in some box type rainwater gutters. This was done to prolong the lifespans of the single ply type liners. A modern cold applied polymer liquid lining is applied to existing linings.

The maintenance and repairs which took place outside of the High Level Maintenance contract are detailed in the tables below:

# 2. A list of the total costs for repairs and annual maintenance to the Scottish Parliament's roof in the past three years.

We do not hold information in a format that allows us to identify the individual costs for repairs and maintenance of the roof as we do not have a contract which focuses exclusively on roof maintenance and repairs. Instead, this is covered in our High Level Maintenance contract, which includes for a dedicated team to provide cleaning, coatings, landscaping and falconry services across the whole site internally and externally for a fixed cost. It is not possible to say what proportion of this contract is dedicated to roof repairs and maintenance as this this subject to change depending on weather conditions and reactive changes which are made to maximise efficiency. The contract runs from and to November each year and the total cost for each year of the request is detailed as follows:

The total costs for the non-contracted project works and reactive repairs for the 3-year period as detailed in the table in response to question 1 are: £164,977.

## 3. A budget forecast for the next three years for identified repairs and annual maintenance of the Scottish Parliament's roof.

At present no repairs have been identified within the stock condition survey. No renewals or upgrades are included in this section of the 25-year investment plan. Any arising needs will be addressed if or when anything occurs. Normal Reactive repairs should be anticipated.

The annual cost of the High Level Maintenance contract is subject to increases due to CPI (the UK Consumer Price Index). This will be effective until 7<sup>th</sup> November 2024 when the current contract reaches the end of its term. The cost for future years is unknown as this is subject to a tendering process yet to be carried out, however it is anticipated that a similar cost will be achieved if the current contract format is used.

As some of the information requested is not held in the format requested by the Scottish Parliament, we have attached a notice advising of this, in line with the requirements of FOI(S)A.
