REQUEST FOR INFORMATION: 2022-682287

We acknowledge receipt of your request for the following information:

I am writing to you to request the following information.

- 1) The total spend, broken down by financial or calendar year, on external legal advice since April 1, 2020. (I.e. 2020/21, 2021/22, 2022/23 to date) 1a) Please break this down by the list of associated cases or disputes, and their individual
- 1b) If possible, please provide the final settlement or damages or other court mandated payment cost for any cases during which external legal advice was sought. If it is not possible to link each case to a settlement agreement, please provide the total cost of the settlements or payments.

Your request was received on 30 November 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

To assist your understanding of the way the SPCB obtains external legal advice, we currently have two contracts, basic details of which can be accessed on the Parliament's Contracts Register. A link to it is provided below. You will see from the Register the broad headings under which we are able to seek external advice. The purpose of each contract is to enable the SPCB to access specialist legal advice as required and assistance at times when business demands on Legal Services resources are particularly high. The service provided under the contracts relates to all aspects of the SPCB's activities and is not limited to what we understand you to mean by "cases" or "disputes". Examples would be development of SPCB employment policies or conditions around contract drafting for specific contracts. For that reason, the figures provided below do not represent expenditure solely on "cases" or "disputes" but

cover all occasions where we have sought legal input from our external legal partners. In addition, the figures below include the cost of external advice relating to the Scottish Government Handling of Harassment Complaints Committee, details of which have been published in the paper dated 6 May 2021 which can be accessed on the Scottish Parliament website at the following link:

We have provided responses to each of your questions below:

1) The total spend, broken down by financial or calendar year, on external legal advice since April 1, 2020. (I.e. 2020/21, 2021/22, 2022/23 to date)

Expenditure under all contracts over £5,000 in value is published in the Contract register | Scottish Parliament Website which is regularly updated. The SPCB contracts are call-offs from the Legal services framework agreements 2019 to 2023 - gov.scot (www.gov.scot).

Below is the legal spend over the last 3 financial years exclusive of VAT:-

Financial Year	Legal spend
2020/2021	£70,156.88
2021/2022	£43,051.00
2022/2023	£14,347.00

Given the references in 1(a) and 1(b) of your request to "cases", "disputes" and "final settlement or damages or other court mandated payment" we have interpreted the focus of your request to be contentious matters.

1a) Please break this down by the list of associated cases or disputes, and their individual cost

Your question assumes that every instruction under the contracts concerns a contentious matter. We have explained above why that is not the case. We can advise that over the course of contract NIC-SER-434A, 24 instructions have been issued up to 30 November 2022, four of which related to contentious matters all of which concerned individuals. We consider that details of these matters are exempt from disclosure under section 38(1)(b) of FOI(S)A but we can advise you that expenditure on the individual matters was £1,749, £3,722, £9,440 and £1,098. These sums are included in the table above. Since we are not disclosing details of individual matters, we are unable advise you of the expenditure attributable to each.

In terms of the technical requirements under FOI(S)A we have attached a notice advising that information under the exemption in section 38(1)(b) will not be disclosed.

Under contract NIC-SER-434B eight instructions were issued, none of which concerned contentious issues.

1b) If possible, please provide the final settlement or damages or other court mandated payment cost for any cases during which external legal advice was sought. If it is not possible to link each case to a settlement agreement, please provide the total cost of the settlements or payments.

We take your request to mean all types of court mandated settlements. No such payments have been made by the SPCB within the timeframe of your request and accordingly this information is not held.

In terms of the technical requirements under FOI(S)A we have attached a notice advising that this information is not held by the Scottish Parliament.
