REQUEST FOR INFORMATION: 2022-682743

We acknowledge your request for the following information:

I would be grateful if you could provide me with all correspondence, reports and other documents since 1 November 2021 about the issue of pigeons at the parliament - or the information contained in such documents - including the use of birds of prey to deal with the problem and any assessment of its success. I hope you can include a Breakdown of Reactive calls to Facilities Management Helpdesk relating to birds/bird prevention, Monthly Reports of bird activity and prevention reports and any discussion about the contract which covers the birds of prey.

Your request was received on 13 December 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

Please find attached the following documents in response to your request:

- Bird reactive calls data
- Pigeon activity report data, including pigeon numbers and prevention data

The name of one member of staff is mentioned in the Bird reactive calls data and has been withheld, as we consider this information to be exempt information under section 38(1)(b) of FOI(S)A – for third party personal data. The reasons in support of the use of this exemption are set out in the attached refusal notice.

In terms of your question regarding "discussion about the contract which covers the birds of prey", the contract with Avian Pest Control Solutions Ltd is not direct with the Parliament. This is delivered as a key subcontract through the High Level Maintenance contract. The current High Level Maintenance contract commenced on 08/11/2017. The contract runs until 07/11/24, after which a new contract will commence. The High Level Maintenance contractor is required to manage key subcontracts using the same standards, service-level agreements and key performance indicators that the main contract is subject to.

As this contract is not direct with the Scottish Parliament, we do not hold information discussing it. In line with the technical requirements of FOI(S)A, we have provided a notice advising of this.
