**The Convener (Stuart McMillan):** Good morning, and welcome to the Delegated Powers and Law Reform Committee's 16th meeting in 2022. Before we move to the first item on the agenda, I remind everyone present to switch mobile phones to silent.

**The Convener:** Under agenda item 2, we are considering two instruments, on which no points have been raised.

#### Criminal Justice Act 1988 (Offensive Weapons) (Amendment, Surrender and Compensation) (Scotland) Order 2022 [Draft]

#### Surrender of Offensive Weapons (Compensation) (Scotland) Regulations 2022 [Draft]

**The Convener:** Is the committee content with the instruments?

#### Members indicated agreement.

**The Convener:** The draft regulations on the surrender of offensive weapons were relaid by the Scottish Government following questions by the committee. The error that the committee highlighted was resolved in the version that is before us this morning.

Mr Simpson wants to comment.

Graham Simpson (Central Scotland) (Con): The two instruments relate to the surrender of, and a compensation scheme for, what are known as zombie knives. Obviously, I am in favour of getting rid of what look to be pretty offensive weapons—if you google "zombie knife", you will see what I mean. However, the lead committee should be absolutely certain that the regulations are clear on what is meant by a zombie knife, as opposed to any other knife. Obviously, the law needs to be absolutely clear, and we do not want knives to slip through the net. We should raise with the lead committee the need for it to be absolutely certain that the instruments are clearly defined.

**The Convener:** Thank you, Mr Simpson. That is a valid point, and I am content for us to raise the issue with the lead committee for it to take into account when it considers the instruments.

### Instruments subject to Negative Procedure

**The Convener:** Under agenda item 3, we are considering five instruments. An issue has been raised on the following instrument.

#### Police Act 1997 (Criminal Records) (Homes for Ukraine Sponsorship Scheme) (Scotland) Amendment Regulations 2022 (SSI 2022/158)

**The Convener:** The instrument amends the Police Act 1997 (Criminal Records) (Scotland) Regulations 2010 (SSI 2010/168) by extending the categories of individuals to whom an exempted question may be asked for the purpose of an enhanced criminal record certificate. That applies to individuals who are seeking to provide accommodation in relation to the homes for Ukraine sponsorship scheme, whether or not they reside in the accommodation themselves.

The instrument was laid on 6 May 2022 and came into force on 12 May. It therefore breaches the 28-day rule in section 28(2) of the Interpretation and Legislative Reform (Scotland) Act 2010. In correspondence with the Presiding Officer, the Scottish Government explained that a breach of the laying requirements had been necessary to ensure that the safeguarding system that is in place is suitable. It also ensures that the appropriate level of checks can be undertaken in advance of matching taking place, given the number of people due to arrive in Scotland in a very short timescale.
