*[The Deputy Convener opened the meeting at 10:00]*

### Interests

**The Deputy Convener (Bill Kidd):** Welcome to the 28th meeting in 2025 of the Delegated Powers and Law Reform Committee. I remind everyone to switch off, or put to silent, mobile phones and other electronic devices.

We have received apologies from Stuart McMillan MSP and Roz McCall MSP; Rona Mackay MSP and Oliver Mundell MSP are here as their substitutes. Jeremy Balfour MSP has also sent his apologies.

The first item of business is a declaration of interests. In accordance with section 3 of the “Code of Conduct for Members of the Scottish Parliament”, I invite Oliver Mundell MSP to declare any interests that are relevant to the remit of the committee.

**Oliver Mundell (Dumfriesshire) (Con):** Although I do not think that it is directly relevant, I draw members’ attention to the fact that I am a board member at Scotland’s Rural College. That might loosely relate to rural support under agenda item 4.

**The Deputy Convener:** Is the committee content that no reporting grounds are engaged?

**The Deputy Convener:** At this stage, Oliver Mundell would like to make a statement.

**Oliver Mundell:** I want to make it clear that I do not support the Early Release of Prisoners (Scotland) Regulations 2025. I believe that it is a disproportionate use of power and that such matters should not be decided by delegated legislation.

**The Deputy Convener:** Thank you for that.

## Instruments subject to Negative Procedure

**The Deputy Convener:** Under agenda item 4, we are considering four instruments. An issue has been raised on the following instrument.

### Prisons and Young Offenders Institutions (Scotland) Amendment Rules 2025 (SSI 2025/277)

**The Deputy Convener:** The instrument makes changes to allow a prison governor to authorise the deputy governor to exercise, on their behalf, the “Governor veto” in relation to early release of prisoners. That is connected to the Early Release of Prisoners (Scotland) Regulations 2025 that we have just considered.

This instrument falls to be reported to the Parliament under reporting ground (j), for a failure to lay the instrument in accordance with section 28(2) of the Interpretation and Legislative Reform (Scotland) Act 2010.

The instrument was laid on 2 October 2025 and will come into force on 10 November 2025, breaching the 28-day rule in the 2010 act, which requires that an instrument must be laid before the Scottish Parliament

“at least 28 days before the instrument comes into force”.

Recess days are excluded for the purpose of counting the days between the instrument being laid and coming into force.

Does the committee wish to draw this instrument to the attention of the Parliament under reporting ground (j), for failure to comply with laying requirements, as it was not laid 28 counting days before it comes into force?

**Members indicated agreement.**

**The Deputy Convener:** Is the committee satisfied with the reasons provided by the Scottish Government for its failure to comply with the laying requirements?

**Members indicated agreement.**

**The Deputy Convener:** Also under this agenda item, no issues have been raised on the following instruments.
