#### Digital Waste Tracking (Scotland) Regulations 2026 [Draft]

**The Deputy Convener:** The purpose of this instrument is to establish a digital waste tracking system in Scotland to track household, industrial and commercial waste. The committee asked the Scottish Government nine questions about this instrument. This correspondence, which has been published alongside the papers for this meeting, sets out in full the committee's questions and the Scottish Government's responses, highlighting several errors in the instrument. The committee's detailed findings will be set out in its report, which will be published in due course and will include its consideration of subordinate legislation at this meeting.

In summary, does the committee wish to draw the instrument to the attention of the Parliament, on the general reporting ground, in respect of the points raised in questions 4, 5, 6, 7 and 8?
