### Interests

The Deputy Convener (John Scott): I welcome committee members and members of the public to the Rural Affairs and Environment Committee's sixth meeting of the year. Liam McArthur has sent his apologies, so we welcome Jim Hume as his substitute. Karen Gillon is on long-term leave, so we welcome Rhoda Grant, who is substituting for her again today.

Agenda item 1 is declarations of interests. I welcome Maureen Watt, who has replaced Roseanna Cunningham as a Scottish National Party member of the committee. I also welcome Jim Hume, who is making his first appearance as a substitute member. I invite them both to declare any interests that are relevant to the committee.
