The Convener (Mr Kenny MacAskill): Good morning. We are quorate—despite the inclement weather.

### Act of Sederunt (Fees of Solicitors in the Sheriff Court) (Amendment) 1999 (SSI 1999/149)

The Convener: We have a short agenda today. We begin with the Executive's responses on statutory instruments. We had raised various matters with regard to SSI 1999/149, and we have received a response that appears to indicate that the Executive may have got this wrong but that that will make no discernible difference. It appears that the Executive has recognised its error; I hope that that error will not be repeated. It is suggested that we highlight the need for care, rather than draw the instrument to the attention of Parliament. Is that agreed?

Members: Yes.

### Act of Sederunt (Fees of Sheriff Officers) 1999 (SSI 1999/150)

**The Convener:** The position with SSI 1999/150 is exactly the same. Again, we have received an acknowledgement of the Executive's error. We will take no action to advise Parliament, now that we have drawn the error to the Executive's attention. Is that agreed?

Members indicated agreement.

### Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (Orkney) (No. 3) (Scotland) Revocation Order 1999 (SSI 1999/159)

**The Convener:** The Executive has acknowledged that the wrong section was referred to in SSI 1999/159, but indicates that no problems arise for the implementation of the instrument. Are we agreed that we should simply note the instrument?

Members: Yes.

### Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (Orkney) (No. 2) (Scotland) Partial Revocation Order 1999 (SSI 1999/160)

**The Convener:** The position with regard to SSI 1999/160 is the same. Again, are we agreed that we simply note the instrument, as we have pointed out the error to the Executive?

Members indicated agreement.
