Standards in Scotland's Schools etc Bill

The Convener (Mr Kenny MacAskill): Good morning. We will make a belated start to our 18th meeting. The first item on the agenda is delegated powers scrutiny. Two matters have been flagged up in relation to the Standards in Scotland's Schools etc Bill as amended at stage 2. The Executive has acknowledged our suggested amendment to section 4 and agreed that the use of delegated powers, consultation requirements and the procedure chosen is entirely appropriate. We can but condemn the Executive—I mean, of course, commend the Executive—for taking our suggestion on board. Secondly, section 56 has been removed, which means that we can now approve the use of delegated powers.
