# Subordinate Legislation Committee

Tuesday 26 June 2001

(Morning)

[THE CONVENER opened the meeting at 11:16]

The Convener (Mr Kenny MacAskill): Good morning and welcome to the 22<sup>nd</sup> meeting in 2001 of the Subordinate Legislation Committee. Today's meeting is our last before the recess.

Before we move on to the formal agenda, I want to note that we had a discussion during our legal briefing about the continuing occurrence of minor errors in the legislation that comes before the committee. Gordon Jackson may have some proposals as to what we should do about that.

Gordon Jackson (Glasgow Govan) (Lab): We are finding lots of errors in legislation. Many of the replies that we receive from the Executive say that we are right and that it has made a mistake and I do not know why that is the case.

Perhaps we should expect a percentage of errors as so many pieces of legislation are drafted. It may be that we are incredibly picky—although that is our job. I have a sneaking feeling that we are finding that more errors occur in the drafting of statutory instruments than might be thought to be appropriate. I am not sure of the answer. Perhaps we could write to the Executive or ask for a meeting. We need to better understand the process and how it works, as that would put our mind at rest.

lan Jenkins (Tweeddale, Ettrick and Lauderdale) (LD): Perhaps, in the sort of meeting with the Executive that we had before, we could ask Executive staff to talk to us about the procedures that are involved. On the other hand, we could write to the Executive asking what its scrutiny procedures are when drafting legislation and before it comes to us.

The Convener: The situation is similar to our views on judicial review—we said that it should not be used as the final court of appeal. Similarly, we should not act as the Executive's checking system; it should have one on board.

I suggest that we write to the Executive, on an informal basis, asking about its current methodology for checking draft legislation before it reaches us. Our remit is to look at legislation from the perspective of the Parliament, not to be a checking house for the Executive. If the Executive has problems with resourcing or with its methodology, that can be discussed.

In the first instance, I suggest that we ask the Executive to clarify matters. It needs to iron out the glitches before legislation reaches us. Does that course of action satisfy members?

**Gordon Jackson:** That would satisfy me. I sound more critical than I want to be. I do not feel well-enough informed to be critical. However, I have a red light in my head alerting me to question why there are so many mistakes—I would like to know the answer.

**The Convener:** Let us find out how the Executive proof reads and checks its legislation.

### Crofting Community Development Scheme (Scotland) Regulations 2001 (SSI 2001/208)

**The Convener:** Item 1 is the consideration of Executive responses.

We should draw the attention of the lead committee and the Parliament to the fact that we pointed out defective drafting in the regulations, which the Executive has acknowledged. That is the point that Gordon Jackson was making. We will leave it to the lead committee to deal with matters hereafter.

# Public Service Vehicles (Registration of Local Services) (Scotland) Regulations 2001 (SSI 2001/219)

The Convener: We raised two matters with the Executive. It has acknowledged the defective drafting of regulation 14(1)(a)(ii) and has undertaken to lay an amending regulation to correct the defect. We also pointed out the error that was found in the explanatory notes to the regulations. We will draw those defects to the attention of the lead committee. The Executive is to sort out the faults in due course.

# Air Quality Limit Values (Scotland) Regulations 2001 (SSI 2001/224)

The Convener: The Executive has acknowledged the issue of defective drafting that we raised on the regulations. As that is the case, I suggest that we draw the attention of the lead committee and of the Parliament to regulation 12 (5).

# Gaming Act (Variation of Fees) (No 2) (Scotland) Order 2001 (SSI 2001/230)

The Convener: Bristow Muldoon and I raised the matter at our previous meeting. The Executive has replied to confirm the recommendations that it received from the National Audit Office. We can draw to the attention of the lead committee the question of whether the massive hike in licence fees should have been staged.

Bristow Muldoon (Livingston) (Lab): I agree with the convener. The issue is one of policy and, as such, it is a matter for the lead committee. We must draw the Executive's response to the attention of the lead committee so that it can come to whatever judgment it sees fit.

# BSE Monitoring (Scotland) Regulations 2001 (SSI 2001/231)

The Convener: We requested further explanation from the Executive regarding the time scale. We have not had a full answer. However, in the case of matters that are quasi foot-and-mouth, our view is that we are sympathetic to the fact that the Executive has had to work under pressure. We should perhaps point out to the Executive that it would be of benefit for us to have an answer to our question as to what happened and why.

I understand from the clerk that we have time only to draw to the attention of the lead committee that we did not receive an explanation from the Executive. We can leave it to the lead committee to push the Executive on that if it so wishes. We could also write to the Executive asking for an explanation to be given to the lead committee. That would give the lead committee our note and anything further that the Executive might say. The lead committee could also approach any member of the Subordinate Legislation Committee on a private basis.

### International Criminal Court (Immunities and Privileges) Order 2001 (Draft)

**The Convener:** We move on to draft instruments that are subject to approval.

We are advised that the order contains a matter that can be drawn to the attention of the Executive in the normal fashion. If members have no comment to make we will move on.

Food Protection (Emergency Prohibitions) (Paralytic Shellfish Poisoning) (West Coast) (Scotland) Order 2001 (SSI 2001/237)

Food Protection (Emergency Prohibitions) (Paralytic Shellfish Poisoning) (Orkney) (No 2) (Scotland) Order 2001 (SSI 2001/241)

**The Convener:** Item 3 is instruments subject to approval. No points arise on the orders.

# Adoption of Children from Overseas (Scotland) Regulations 2001 (SSI 2001/236)

The Convener: Item 4 is instruments subject to annulment.

The regulations breach the 21-day rule and I am curious to know why that is the case. During the legal briefing, we discussed an adoption case that appeared in the newspapers. Given that adoption law is being reviewed, however, we could ask the Executive why it is rushing the regulations, unless it is so that they can be passed contemporaneously with English legislation.

### Water Supply (Water Quality) (Scotland) Amendment Regulations 2001 (SSI 2001/238)

**The Convener:** No points arise on the regulations.

# Protection of Wrecks (Designation) (Scotland) Order 2001 (SSI 2001/242)

### Import and Export Restrictions (Footand-Mouth Disease) (Scotland) (No 2) Amendment Regulations 2001 (SSI 2001/243)

**The Convener:** No points arise either on the order or the regulations.

### Adoption (Intercountry Aspects) Act 1999 (Commencement No 6) Order 2001 (SSI 2001/235)

**The Convener:** We will draw the Executive's attention to a minor drafting matter, in the usual fashion.

That concludes our agenda and brings the parliamentary term to an end for this committee. I am grateful to members for their assistance and co-operation.
