The Deputy Convener (lan McKee): Welcome to the 25th meeting in 2010 of the Subordinate Legislation Committee. We have apologies from Jamie Stone, which is why I am convening the committee. I ask members to turn off any mobile phones, BlackBerrys and so on.

Under agenda item 1, I seek the committee's agreement to consider item 5 in private. Item 5 concerns a discussion of a draft report on the delegated powers in the Legal Services (Scotland) Bill, as amended at stage 2. Do we agree to consider the item in private?

The Deputy Convener: Are we content with the explanation provided by the Scottish Government for the breach of the 21-day rule between the laying of this order and the coming into force of the provisions—apart from articles 2(3) and 3, which comply with the rule?

Members indicated agreement.

The Deputy Convener: Do we agree to report that the meaning of articles 2(2)(b) and 2(3)(b) could be clearer in relation to the extent to which persons are to be treated as "qualified to teach" archery and a water sport, respectively? The committee might consider clarity to be particularly important, as only qualified persons who hire out, and so on, an arrow for archery or a knife for a water sport for safety purposes will be exempt from the requirement to hold a licence, and hiring and so on without a licence is a criminal offence. Do we agree to the recommendation?

Equality Act 2010 (Qualifications Body Regulator and Relevant Qualifications) (Scotland) Regulations 2010 (SSI 2010/315)

The Deputy Convener: It is recommended that we agree to report that the meaning of regulation 3 could have been clearer in the following respects. First, it appears that it would have been possible, in the regulation, to prescribe the particular qualifications, which are relevant qualifications, in a clearer way than by referring to them as those known as

"national qualifications in Scotland"

at the date of making the regulations. Secondly, the regulation could have specified, as explained in the last paragraph of the explanatory note, that the national qualifications to be introduced under the curriculum for excellence are included as prescribed "relevant qualifications". Do we agree to the recommendation?
