[THE CONVENER opened the meeting at 14:04]

The Convener (Mrs Mary Mulligan): Good afternoon everybody. Let us make a start. I begin this afternoon's meeting by welcoming Margaret Ewing to the committee. Margaret, yours could be the shortest membership ever, unless you are putting in a bid for Mike Russell's place.

Mrs Margaret Ewing (Moray) (SNP): No, he is too big for me.

Cathy Peattie (Falkirk East) (Lab): Do not let that put you off.

The Convener: Margaret, do you have any interests to declare?

Mrs Ewing: I cannot think of any. I was a teacher, with a special certificate in what then was called remedial education, but I am not involved with any unions or anything like that.

lan Jenkins (Tweeddale, Ettrick and Lauderdale) (LD): You must be a lot older than you look if you have a certificate in remedial education.

The Convener: The first item on the agenda is to decide whether to hold the discussion on the forward work programme in private.
