# **Interests**

**Bill Walker (Dunfermline) (SNP):** Good morning, everyone. Welcome to the first meeting of the Local Government and Regeneration Committee in the fourth session of the Scottish Parliament.

First, I remind all those present, including members, that mobile phones and BlackBerrys should be turned off completely as they interfere with the sound system even when they are switched to silent. I have just realised that I have one here. I beg your pardon. I did this in the last committee as well. Tut, tut.

For the benefit of new members, I point out that the sound operator will switch on your microphone when you speak. You do not need to fiddle about with the gubbins yourself.

Under rule 12.1.6 of standing orders, the first meeting of a committee after it is established by Parliament shall be chaired by the oldest member of the committee until a convener is chosen. I am that member, so welcome to all you dreadfully young people. [Laughter.]

The first item on the agenda is a declaration of interests. In accordance with section 3 of the code of conduct for members of the Scottish Parliament, I invite members to declare any interests that are relevant to the committee's remit. I remind members that any declaration should be brief but sufficiently detailed to make the nature of the interest clear to any listener. I will start, then we will go round the table. I ask each member to give their name and then declare any interests.

Like several of you, I am an existing councillor—I am a member of Fife Council—so that is my first interest. Obviously, I will state that when anything comes up regarding Fife Council, and similarly for the regeneration aspect of the committee's work. I am also involved in various voluntary organisations as a Fife councillor but I am trying to extricate myself from some of those as the year goes on. I will be a councillor only until next May. I plan to declare anything that touches at all on what we might do during the year.

Kevin Stewart (Aberdeen Central) (SNP): I am a member of Aberdeen City Council.

Joe FitzPatrick (Dundee City West) (SNP): I have no relevant interests to declare.

**David Torrance (Kirkcaldy) (SNP):** I am an elected member of Fife Council.

**Ruth Davidson (Glasgow) (Con):** I have no relevant interests to declare.

Mark Griffin (Central Scotland) (Lab): I am an elected member of North Lanarkshire Council.

**Kezia Dugdale (Lothian) (Lab):** I have no relevant interests to declare.

**Bill Walker:** Thank you, everyone. I obviously spoke far too much.

**Bill Walker:** I congratulate Joe on his appointment and hand over the chair to him for the remainder of proceedings. Thank you, everyone.

The Convener (Joe FitzPatrick): Thank you. It is a real honour for me to have been asked to serve in this post on what is a very important committee in the Parliament. People have commented that, apart from me, all the members of the committee are from the new intake of MSPs. As a new convener, I am hoping that that will give me a little bit of leeway and that if I make any mistakes, you will not notice.

Despite the array of fresh faces on the committee, I know that members' collective expertise, particularly with regard to local government and from work with previous MSPs, will serve us well as we take our work forward.

**The Convener:** I think that that would be useful. It will certainly form part of what the minister will have to say to us, but perhaps we should get SPICe to prepare a briefing on that.

**Kezia Dugdale:** That would be very helpful.

**The Convener:** If there are no other comments, I formally propose that we invite the Minister for Local Government and Planning to our next meeting on 22 June to give evidence on the Scottish Government's priorities in relation to local government and regeneration.

**Bill Walker:** Excuse me, convener, but I think that you said that she is the Minister for Local Government and Planning. Is she not minister for local government and regeneration?

**The Convener:** Did I say planning? I meant regeneration.

Bill Walker: Have I got that wrong?

**The Convener:** I am sorry—she is the Minister for Local Government and Planning.

Bill Walker: I beg your pardon.

**The Convener:** Her title is slightly different from the name of our committee.

Do members agree to my proposal?

Members indicated agreement.

**The Convener:** Do members also agree to have a discussion in private after that meeting?

Members indicated agreement.

The Convener: Finally, I ask the committee whether it agrees to hold towards the end of the summer recess a planning day, the details of which the clerks will discuss with members in due course.

Members indicated agreement.

**The Convener:** Our next meeting will be on Wednesday 22 June at 10 am.
