## **Subordinate Legislation**

# Equality Act 2010 (Specific Duties) (Scotland) Regulations 2012 [Draft]

The Convener: Agenda item 1 is subordinate legislation. On 1 May we will take ministerial evidence on and debate a draft Scottish statutory instrument—the Equality Act 2010 (Specific Duties) Scotland Regulations 2012. We are asked to note the submissions that have been received and to consider whether to take any action in advance of the evidence session on 1 May.

**John Finnie:** I note that the letter from the Minister for Community Safety and Legal Affairs mentions a planned meeting between officials and Friends of the Earth Scotland on 19 April. We should await the outcome of that meeting before doing anything.

The Convener: I agree.

**Stuart McMillan:** I was going to suggest the same thing.

The Convener: It seems sensible to wait until we get feedback from that meeting before we make any other decisions.
