### PE1934: Develop an educational resource on gender-based violence for all year groups in High School

#### Petitioner

#### Date Lodged

#### **Petition summary**

Calling on the Scottish Parliament to urge the Scottish Government to work with Education Scotland to develop an educational resource on gender-based violence for all year groups in High School. This resource should –

- Educate on the causes of gender-based violence and

- Ensure that young people leave school with the tools to help create a safer society for women

#### **Previous action**

We have written to our local MSP Jamie Hepburn, who in turn contacted the Education Secretary who wrote to our group. In the response Shirley-Ann Sommerville outlined what the government already do. We asked the Education Secretary about mandatory lessons, however she informed us that the government does not "prescribe" what is to be taught in schools. We have also conducted a survey to find out if young people felt enough was taught about this issue in school. 85% of respondents said no, there was not enough teaching.

#### **Background information**

During the period between March and September 2021, 81 women were killed at the hands of men in the UK. Violence against women is an issue felt disproportionately by women of colour and trans-women. Among the 375 transgender people killed in 2021 globally, the vast majority were black transgender women (Forbes, 2021). Gender based violence increased during the COVID-19 pandemic, where reported cases increased dramatically due to national lockdowns. It was predicted there would be an additional 31 million gender-based violence cases if lockdown only lasted 6 months, the final figure will be devastatingly larger due to prolonged lockdowns. In Scotland alone, there were 65,000 cases of domestic abuse reported last year, the fifth time in a year it has risen.

It is our goal to help tackle violence against women, which destroys too many lives every year. We believe that educating our children will end any existing cycles of gender-based violence and prevent any new ones from starting.

# Annexe B: Extract from Official Report of last consideration of PE1934 on 9 October 2024

**The Convener:** Petition, PE1934, from Craig Scoular, on behalf of Greenfaulds high school rights and equalities committee, calls on the Scottish Parliament to urge the Scottish Government to work with Education Scotland to develop an educational resource on gender-based violence for all year groups in high school. The resource should educate on the causes of gender-based violence and ensure that young people leave school with the tools to help them to create a safer society for women.

We last considered the petition at our meeting on 8 November 2023, when we agreed to write to the Cabinet Secretary for Education and Skills and the University of Glasgow. At that time, the cabinet secretary indicated that the gender-based violence in schools working group was expected to publish its national framework to help schools to tackle sexual harassment and gender-based violence.

The framework has been published, and the cabinet secretary has stated that the Scottish Government has committed to commissioning an independent review to establish positive practice and further areas for improvement during this parliamentary session. The submission also highlights the revised statutory teaching guidance, which includes a section to support learning and teaching on consent and healthy relationships. The Scottish Government consulted on the guidance last year and is analysing the responses.

Meanwhile, the University of Glasgow's written submission provides details of its evaluation of the equally safe at school intervention. The aim of the evaluation is to determine whether the intervention is effective, including cost effective. Its work will take place with six schools over two years, with the full results expected in December 2026.

Colleagues, do you have any suggestions?

**Foysol Choudhury (Lothian) (Lab):** We should write to the Cabinet Secretary for Education and Skills to ask what the next steps will be following the publication of the gender-based violence in schools framework, when the Scottish Government intends to commission an independent review of the framework and when it expects that review to conclude.

**The Convener:** As there are no other suggestions, are colleagues content with that approach?

#### Cabinet Secretary for Education and Skills written submission, 3 December 2024

## PE1934/I: Develop an educational resource on gender-based violence for all year groups in High School

Thank you for your letter of 18 October 2024 on behalf of the Citizen Participation and Public Petitions Committee regarding Petition PE1934 to develop an educational resource on gender--based violence for all year groups in high school.

The Committee has requested information on when the Scottish Government intends to commission an independent review of the Gender-Based Violence in Schools Framework and when it is expected to conclude.

I have committed to commissioning an independent review of the framework to establish positive practice and further areas for improvement, before the end of this parliamentary session. However, I also require sufficient time for schools to implement this framework ahead of the independent review. It is my intention to commission the review ahead of March 2026. The timetable for the review will be set as part of the process of commissioning.

The Committee may wish to note that our relationships and behaviour in schools action plan, published in August 2024, includes an action to empower staff to support relationships and behaviour approaches and practice and to respond to emerging trends in behaviour. This includes scoping development of learning on emerging areas of concern, including gender-based violence and far-right extremism. As a first step in the delivery of this action, Education Scotland ran an information session on the framework for school staff in September 2024. Education Scotland will use the feedback from that session to determine if there are any areas where more bespoke training may be helpful.

I hope the Committee finds the information in this letter helpful.
