# Consideration of Member's Bills – Session with Members-in-charge

# Introduction

### Prevention of Domestic Abuse (Scotland) Bill

- 1. At its meeting on 25 June 2025, the Criminal Justice Committee will take evidence from Pam Gosal MSP, the Member-in-charge of the Prevention of Domestic Abuse (Scotland) Bill. This Member's Bill was introduced on 7 May 2025 and aims to strengthen prevention, information-sharing, and rehabilitation approaches in response to domestic abuse in Scotland.
- 2. The session is part of the Committee's scrutiny of the Bill at Stage 1 and follows its formal referral by the Parliamentary Bureau.
- 3. The session will also involve officials from the Scottish Parliament's Non-Government Bills Unit (NGBU), who supported the development of the Bill.

# Prostitution (Offences and Support) (Scotland) Bill

- Following the evidence session with Pam Gosal MSP, the Committee will take evidence from Ash Regan MSP, the Member-in-charge of the Prostitution (Offences and Support) (Scotland) Bill. This Member's Bill was introduced on 20 May 2025.
- 5. The session is part of the Committee's scrutiny of the Bill at Stage 1 and follows its formal referral by the Parliamentary Bureau.
- 6. The Bill creates a new offence of paying for sexual acts. The Bill also repeals the existing offence under section 46 of the Civic Government (Scotland) Act 1982 of soliciting and importuning by prostitutes. People who have been convicted of this offence in the past would have their convictions quashed. Additionally, Scottish Ministers will need to ensure that a person who is, or has been, in prostitution is provided with help and support.
- 7. Ash Regan MSP will be accompanied at the session by members of her office who have been involved in the development of the Bill.
