## National Planning Framework

## Background

1. The draft fourth National Planning Framework (NPF4) work was published on 10 November 2021—

- Scotland 2045 fourth National Planning Framework draft: consultation
- 2. The following were also published—
  - National developments assessment summary report
  - Housing Land Figures: Explanatory Report
  - Regional Spatial Strategies
  - Data insights for each of the 5 Action Areas
- 3. On 29 November 2021, an Integrated Impact Assessment was published—
  - Integrated Impact Assessment
- 4. The following accompanied the Impact Assessment—
  - Research Project: Lifecycle Greenhouse Gas Emissions of NPF4 Proposed National Developments Assessment Findings
  - Habitats Regulations Appraisal of NPF4 Initial Screening Record
  - Habitats Regulations Appraisal of NPF4 Updated Baseline Information Report

5. The Minister for Public Finance, Planning and Community Wealth made a <u>statement to Parliament</u> on 10 November 2021 on the laying of the draft fourth National Planning Framework.

### Background

7. The National Planning Framework is the spatial expression of Scottish Government policy.

8. The Town and Country Planning (Scotland) Act 1997, as amended by the Planning etc. (Scotland) Act 2006 and the Planning (Scotland) Act 2019, provides the legislative framework for the National Planning Framework (NPF).

9. It requires that a strategy for spatial development<sup>1</sup> be created and should include a statement of what Scottish Ministers consider to be priorities for development<sup>2</sup>. It should also contain—

- Targets for the use of land in different areas of Scotland for housing<sup>3</sup>
- An assessment of how proposed national developments<sup>4</sup> and the strategy as a whole<sup>5</sup> will impact on the achievement of greenhouse gas emission targets;
- An indication of how the strategy will meet housing needs<sup>6</sup>, improve health and wellbeing<sup>7</sup>, repopulate rural areas<sup>8</sup>, improve equality<sup>9</sup> and secure "positive effects for biodiversity"<sup>10</sup>.
- 10. The NPF4 will-

"incorporate <u>Scottish Planning Policy (SPP)</u> which contains detailed national policy on a number of planning topics. For the first time, spatial and thematic planning policies will be addressed in one place."<sup>11</sup>

### Scottish Parliamentary Scrutiny

11. The Local Government, Housing and Planning Committee considered its approach to consideration of the framework on 2 November 2021 and 16 November 2021. It agreed to propose a collaborative approach to scrutiny and <u>wrote</u> to the following committees—

- Net Zero, Energy and Transport Committee
- Rural Affairs, Islands and Natural Environment Committee
- Economy and Fair Work Committee
- Health, Social Care and Sport Committee
- Equalities, Human Rights and Civil Justice Committee

12. The Committee also <u>wrote</u> to the following committees informing them of its upcoming inquiry—

- Social Justice and Social Security Committee
- Public Audit Committee
- Finance and Public Administration Committee

13. The Committee also <u>wrote</u> to the Scottish Parliamentary Bureau on the timescales for consideration of the final Framework.

- 14. The collaborative approach includes—
  - That the subject committees take the lead in scrutinising policies and proposals within their remit;
  - To run a single call for views for all committees
  - To maximise the time available for scrutiny by each committee taking evidence on issues within their remit (which will allow time for committees to take evidence from their Cabinet Secretaries);
  - To invite committees to write to relevant Cabinet Secretaries and the Local Government, Housing and Planning Committee with their conclusions;
  - To include the correspondence of other committees in the report of the Local Government, Housing and Planning Committee, along with detail of common threads; and
  - To seek to lodge a motion in the names of all committees who reported on the draft NPF4 for a Chamber debate.
