Scottish Housing Regulator Annual Report 2020-21

Introduction

- 1. The purpose of this paper is to provide information for the Committee's evidence session with the Scottish Housing Regulator (SHR) on its Annual Report for 2020-21, published on 19 November 2021.
- 2. The Committee will take evidence on the SHR's Annual Report from—
 - George Watson, Chair; and
 - Michael Cameron, Chief Executive

- 4. The SHR has also provided a short summary of some of the work that it has undertaken since the period covered by the Annual Report. This update is attached as an annexe.

Background

- 5. The SHR is an independent Non-Ministerial Department, established on 1 April 2011 under the Housing (Scotland) Act 2010.
- 6. Its statutory objective is to safeguard and promote the interests of—
 - around 600,000 tenants who live in homes provided by social landlords
 - over 120,000 owners who received services from social landlords
 - around 40,000 people and their families who experience homelessness and seek help from local authorities

- around 2,000 Gypsy/Travellers who can use official sites provided by social landlords.
- 7. The main functions of the SHR are to—
 - keep a publicly available register of social landlords;
 - monitor, assess and regularly report on all social landlords' performance of housing activities and on registered social landlords' financial well-being and standards of governance;
 - take action, where necessary, to protect the interests of tenants and other service users.
- 8. The SHR regulates 158 registered social landlords (RSLs) and the housing activities of Scotland's 32 local authorities. The Act requires that the SHR carries out its functions in a proportionate, accountable and transparent way. The SHR is led by a Board of non-executive members, appointed by Scottish Ministers following an open public appointments process.
- 9. The previous Local Government and Communities Committee last met with the SHR in November 2020 to discuss its Annual Performance Report and Accounts for 2019/20. The Official Report of that session can be accessed via the following link—

ANNEXE

Scottish Housing Regulator Submission to the Local Government, Housing & Planning Committee, 15 March 2022

SHR will meet with the Committee on 22 March 2022 to scrutinise the 2020/21 Annual Report and Accounts. As a significant amount of time has passed since March 2021, we have set out below a summary of some of the work that SHR has done since then.

We have:

- continued to work with colleagues in the Social Housing Resilience Group, publishing quarterly dashboards on the impact of Covid-19 on social landlords;
- continued to update our guidance for Registered Social Landlord (RSL) governing body members during Covid-19;
- published research of Covid's impact on landlords' services and tenant quality of life gathered via our National Panel of Tenants and Service Users;
- welcomed two new Board members Maireke Dwarshuis and Lindsay Paterson, appointed by Scottish Ministers;
- ended intervention at Thistle and Fairfield Housing Associations we have no live statutory intervention cases;
- published information on how we use our statutory powers and accounts of our previous intervention at Wishaw & District, Arklet, Ruchazie and Thistle Housing Associations. Our account on the outcome of intervention in Fairfield Housing Association will follow;
- carried out significant recruitment, including appointed seven staff new to SHR and as well as a number of internal promotions of existing colleagues.
 Recruitment included appointing a new Director of Regulation Helen Shaw, following Ian Brennan's retirement last month. The impact of the pandemic, and a range of challenges in the overall Scottish Government recruitment process, resulted in delays in making these appointments, which impacted our work plans.

We also:

- reported on our analysis of RSL Loan portfolio and RSL finances;
- gathered and published Annual Assurance Statements for all social landlords;
- kept our engagement plans updated including the regulatory status for RSLs during the year;
- worked with SFHA, GWSF and ALACHO on a new guide to support social landlords with equality data collection;
- published our annual national report on the Charter and updated companion products including our comparison tool and individual landlord reports;
- wrote to landlords to highlight the importance of gas safety;
- deregistered a number of RSLs after they transferred their homes to other RSLs;
- published the risks we are focusing on in our ongoing risk assessment, which will report at the end of March 2022;
- started to recruit a new cohort of volunteer Tenant Advisors to inform our work;
- surveyed social landlords on tenant health and safety;
- published de-registration guidance for RSLs;
- spoke to all local authorities about their homelessness services; and
- continued to support our staff to work at home and more recently facilitated a
 gradual return to working from our office.
