Analysis of Congratulatory Motions in the Scottish Parliament

This paper summarises the results of an analysis on the number of motions with a congratulatory theme, "congratulatory motions", from the beginning of Session 1 to Session 6 (until 31 March 2023).

Summary and Key Trends

- The percentage of congratulatory motions lodged appears to increase each Session from Session 1 to Session 5.
- From the available search data, Session 5 marks a peak in the percentage of congratulatory motions being lodged.
- Compared to Session 5, there appears to be a slightly smaller percentage of congratulatory motions being lodged in Session 6.
- Within each Session, the percentage of congratulatory motions tends to increase each Parliamentary year before stabilising or decreasing in the final Parliamentary year (noting that Session 5 does not wholly follow this trend).
- When comparing each Session with Session 6, the rate of change in Parliamentary motions being lodged appears to be slowing.

Notes on Screening Criteria and Motions Search

In undertaking this analysis, SPICe applied a conservative screening criterion for congratulatory motions. The criterion was that the motion began with or included the term "That the Parliament congratulates". There is a possibility that with this screening criteria, local motions or other congratulatory motions (made using different terms) are not included in this spot check analysis. Fallen motions are also included in the outcomes of the search as the database of Parliamentary motions does not permit the exclusion of such motions from search returns.

Parliamentary years were selected using the dates recorded in the **SPICe Factsheet**.

The Parliament does not hold data on motions in a format that permits the detailed exploration and examination of the contents of Parliamentary motions at scale. Therefore, SPICe is not able to provide detailed insights on the topic and intent (e.g., whether the motion referred to a local cause) of congratulatory motions.

Analyses

For each Session and each Parliamentary year from Session 1 to Session 6 (until 31 March 2023), the following data is reported:

- Total Motions
- Total Congratulatory Motions (CMs) (as per screening criterion)
- Percentage of Congratulatory Motions.

SPICe advises that percentages, rather than the numerical totals of motions, should be read for any comparisons. This is because the total number of motions in each Session and Parliamentary year varies, and the length of each Session and Parliamentary year also varies.

Figure 1: Bar chart showing the percentage of congratulatory motions lodged in the Scottish Parliament for Session 1 to Session 6.



Figure 2: Bar chart showing the percentage of congratulatory motions lodged in each Parliamentary year from Session 1 to Session 6.


